ASU and DSC Consolidation Implementation Committee Meeting Albany State University Lovett Hall Thursday, June 2, 2016 10:00 a.m. – 12:00 p.m.

The ASU and DSC Consolidation Implementation Committee meeting was held on Thursday, June 2, 2016. The meeting was called to order by Arthur Dunning, Albany State University President at 10:05 a.m.

President Dunning welcomed the group and thanked everyone for their continued efforts during the consolidation. Richard Carvajal, Interim President of Darton State College, reiterated his sentiments and welcomed the OWG committee co-chairs; he then introduced new CIC Members, Shawn McGee, VP Fiscal Affairs, and Chantal Johnson, SGA President of Darton State College. Danette Saylor and Cynthia George joined via telephone.

Kevin Scott discussed the history document and asked for comments as today is the last day for submissions; the final draft will be submitted to the presidents. President Carvajal thanked K. Scott for the hard work in the creation and revision of this document.

President Carvajal announced the possibility of releasing the Vision Statement and collective history statement next week.

Randy Stuart began by discussing the OWG recommendations that appeared on the Consent and Discussion agendas. The Consent Agenda was discussed first:
